

# Auburn CityFest 2022 Juried Art Show

Saturday, April 30, 2022 • 9 a.m. – 4 p.m. • Kiesel Park, Auburn, AL

- Open to artists 18 years of age and older located in Alabama, and the states adjacent (GA, MS, FL and TN).
- Artists may submit one work in any fine art medium including: painting, works on paper, three-dimensional works (ceramics/sculpture), mixed-media, jewelry and photography.
- Awards: Ten cash awards, including two, \$250 awards, presented by the Auburn-Opelika Tourism Bureau, will be selected by the award jurors. There will also be a \$200 photography award.
- A Preview Reception, open to the public, will be held on Thursday, April 28, 2022 from 5:30 - 7:30 p.m. at the Historic Nunn Winston House at Kiesel Park. If your work will be available for sale, no commission will be charged.
- Artists are responsible for the insurance on their work and sales tax.
- Works will be displayed at Kiesel Park on Saturday, April 30, 2022 from 9 a.m. - 4 p.m. Awards will be announced at the Preview Reception. Artists should pick up work at Auburn CityFest between 4 - 5 p.m. on April 30, 2022.
- Artists are responsible for mailing or delivering works to the Jan Dempsey Community Arts Center for the preview and public exhibition. A \$25 entry fee payable in advance is charged. The fee is waived for artists purchasing exhibitor spaces.
- Entry forms and fees are due by Monday, April 25, 2022. Works are due at the Jan Dempsey Community Arts Center, on Monday, April 25, 2022. The Arts Center's physical address is 222 E. Drake Ave. Auburn, Ala., the mailing address is 425 Perry St., Auburn, Ala. 36830.
- Checks should be made payable to the Auburn Arts Association.
- Out of town exhibitors must mail a work by Friday, April 22, 2022.
